This is to certify that the Department of Energy has duly authorized;

This Certificate of Authority shall serve as the Department's exclusive endorsement for Offshore Wind Energy Developer to secure the necessary permits or certifications and tenurial instruments from government agencies, entities or instrumentalities having jurisdiction over any aspect of the wind energy exploration, development and operations.

This certification is issued in compliance with the requirements provided under Department Circular (DC) No. _____ "Revised Omnibus Guidelines Governing the Award and Administration of Renewable Energy Contracts and the Registration of Renewable Energy Developers" of the Department of Energy (DOE). The certification shall be subject to the following terms and conditions:

- 1) *Date of Issuance – The date of issuance shall be the date when the Offshore Wind Energy Developer affixes its signature in conformity with the conditions set forth herein.*
- 2) *This certification is exclusively authorizing the Offshore Wind Energy Developer within the maximum period of five (5) years to procure necessary permits or certifications and tenurial instruments needed for the exploration, development, and utilization of the wind energy resources within an area specified in the Offshore Wind Energy Service Contract (OWESC) Application, and conduct reconnaissance and other activities needed for pre-feasibility studies as indicated in the Work Plan made an integral part of this Certificate as Annex A.*
- 3) *Location Description –The location of the proposed _____ Offshore Wind Power Project situated in the Municipality of _____, Province of _____ and particularly bounded within the geographic coordinates indicated in Annex B (Verification Map issued by the ITMS) hereof.*
- 4) *The Offshore Wind Energy Developer under this Certificate shall be subject to the following obligations:*
 - a) *Immediately report to the DOE any changes such as change in the location and the expansion of its utilization, among others; and*
 - b) *Submit quarterly progress and annual reports.*
- 5) *Effectivity and Duration – shall take effect on the Date of Issuance and shall remain valid for a period not exceeding five (5) years.*

Failure to give written notice within the five (5) -year period to execute the OWESC shall be deemed abandonment of the OWESC Application as stipulated in Section ____ of DC No. _____.
