In reference to the approved contract awarded through BAC Resolution No. 006 s. 2023 and Notice of Award No. 2023-01-006-NOA006 for the "Procurement of Services for the DOE CY2023 Secondary Internet Access" in the amount of **Eight Hundred Ninety-Nine Thousand Eight Hundred Pesos Only (Php899,880.00)** for ten (10) months from March to December 2023, resolved and adopted by the DOE-Bids and Awards Committee (BAC) during its BAC meeting and deliberation last 24 January 2023.
2. Section 37 of the 2019 Revised Implementing Rules and Regulation (IRR) of Republic Act No. 9184 states that:

37.4.1. The concerned Procuring Entity shall issue the Notice to Proceed (NTP) together with a copy of the approved contract to the successful bidder within seven (7) calendar days from the date of approval of the contract by the appropriate government approving authority.
