- 2. The **DOE Bids and Award Committee (DOE-BAC)** now invites technically, legally, and financially capable suppliers for the said project.
- 3. The Procurement procedure for this requirement is **Negotiated Procurement for Two-Failed Bidding (AMP 53.1)** pursuant to Section 53.1 of 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

The selection of the successful offer shall be based on the best and final offer that will be submitted on the set deadline by the BAC and which would meet the minimum technical specifications required.

- 4. The interested bidders may obtain further information from the BAC Secretariat at the address given below from **29 November 2024** to **06 December 2024**, Monday to Friday, at 8:00AM to 4:00PM.
- 5. The **DOE** will hold a Negotiation Meeting on **05 December 2024 at 9:00AM** at **OIMB Conference Room**, which shall be open to prospective bidders.
- 6. Two (2) copies of the proposals (one original and one copy) must be submitted to the BAC which must be duly received by the BAC Secretariat through manual submission at the office address indicated above on or before **3:00 PM of 06 December 2024**. Late submission shall not be accepted.
- 7. Interested bidders shall submit the following documents in sealed envelopes, labeled as "Negotiated Procurement for Two-Failed Biddings", with the title of the procurement project, name of the bidder, address, the contact details of the bidder, addressed to the BAC.

In case of Joint Venture, Special Power of Attorney shall be submitted by all members of the joint venture giving full power and authority to its officer to sign the OSS and do acts to represent the Bidder.
