Resolution No. <u>438</u> s. 2023

A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THROUGH THE USE OF ALTERNATIVE MODE OF PROCUREMENT (AMP), FOR THE PROCUREMENT OF PROMOTIONAL ITEMS/MATERIALS FOR THE IEC, HSSE-IMT AND TC FOR STANDARD DEVELOPMENT OF NATURAL GAS FACILITIES, PRODUCT AND CODE OF PRACTICE AND OTHER SUPPLIES

WHEREAS, the Bids and Awards Committee (BAC) received a memorandum dated 13 June 2023 from Director Rino D. Abad of the Oil Industry Management Bureau (OIMB) requesting the BAC's approval through the use of AMP for the Procurement of Promotional Items/Materials for the IEC, HSSE-IMT and TC for Standard Development of Natural Gas Facilities, Product and Code of Practice and Other Supplies with an approved budget for the contract of One Hundred Sixty-Nine Thousand Eight Hundred Pesos Only (Php169,800.00);

WHEREAS, this procurement has been included in the Department's CY 2023 Annual Procurement Plan approved by the Secretary Raphael P. M. Lotilla;

WHEREAS, Sections 48.1, 53 and 53.10 Rule XVI of the 2016 Revised IRR of Republic Act (RA) No. 9184 authorized the conduct of Negotiated Procurement under the AMP, the pertinent provisions of which are quoted as follows:

"Sec. 48.1 Alternative Methods. — Subject to the prior approval of the Head of the Procuring Entity, and whenever justified by the conditions provided in this Act, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in this Rule. In all instances, the procuring entity shall ensure that the most advantageous price for the Government is obtained:

"Sec. 53. Negotiated Procurement is a method of procurement of goods, infrastructure projects and consulting services whereby the procuring entity directly negotiates a contract with a technically, legally, and financially capable supplier, contractor or consultant only in the following cases;

"Sec. 53.10. Lease of Real Property and Venue. Lease of real property and venue for official use, subject to Annex "H" of this IRR."

- APPROVE the BAC-TWG findings and recommendation for the award of contract for the Procurement of Promotional Items/Materials for the IEC, HSSE-IMT and TC for Standard Development of Natural Gas Facilities, Product and Code of Practice and Other Supplies (208 pcs. Insulated tumblers) in the amount of One Hundred ThreeThousand Five Hundred Eighty Four Pesos (Php103,584.00);
- RECOMMEND to the Head of Procuring Entity, the approval of the award of the above-mentioned contract; and,
- 3. **FURNISH** the Commission on Audit, for its information and reference, a copy of this Resolution immediately after its approval by the Head of Procuring Entity;
