A RESOLUTION RECOMMENDING THE AWARD OF CONTRACT THROUGH THE USE OF ALTERNATIVE MODE OF PROCUREMENT (AMP), IN PARTICULAR NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) FOR THE PROCUREMENT OF MINDANAO FIELD OFFICE TABLES AND CHAIRS

WHEREAS, the Bids and Awards Committee (BAC) received a memorandum dated 08 May 2023 from Keezha Bea J. Soterno of Finance and Administrative Section for the BAC's approval through the use of Alternative Mode of Procurement (AMP), the Procurement of Mindanao Field Office Tables and Chairs with an approved budget for the contract of Php 70,000.00;

WHEREAS, this procurement has been included in the Department's CY 2023 Annual Procurement Plan approved by the Secretary Raphael P.M. Lotilla;

WHEREAS, Sections 48.1, 53 and 53.9 Rule XVI of the 2016 Revised IRR of R.A. No. 9184 authorized the conduct of Negotiated Procurement under the AMP, the pertinent provisions of which are quoted as follows:

Sec. 48.1 Alternative Methods. — Subject to the prior approval of the Head of the Procuring Entity, and whenever justified by the conditions provided in this Act, the • Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in this Rule. In all instances, the procuring entity shall ensure that the most advantageous price for the Government is obtained:

"Sec. 53. Negotiated Procurement is a method of procurement of goods, infrastructure projects and consulting services whereby the procuring entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant only in the following cases;

"Sec. 53.9. Small Value Procurement. Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribe in Annex "H" of this IRR: Provided, That in case of Goods, the procurement does not fall under Shopping in Section 52 of this IRR"

WHEREAS, the SBAC thru its Secretariat had posted this item for procurement in the websites of DOE and PhilGEPS on 10 June 2023 to 15 June 2023 to ensure widest dissemination and to receive competitive price quotations thereof;

WHEREAS, the SBAC received Five (5) quotations from website postings and three (3) Quotation from the end-user which was endorsed to the SBAC-Technical Working Group (TWG) for evaluation, details are as follows;

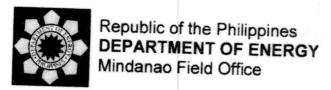
