<b>I.</b>	<b>BACKGROUND</b> The <b>Department of Energy (DOE)</b> , hereunto referred to as the <b>CLIENT</b> , needs the services of a duly accredited, capable, competent, and stable training provider endorsed by the Commission which specializes on both online and in-person review classes for the CSE Professional and Subprofessional Levels.
<b>II.</b>	<b>SCOPE OF WORK / BRIEF DESCRIPTION OF THE ASSIGNMENT</b>  a) The <b>Service Provider</b> through the review courses will help the learners by providing review of basic preparation for the Civil Service Examination.  b) The <b>Service Provider</b> will conduct the program for 35 employees for an in-person session with a total of 60 hours or 20 sessions.  c) The <b>Service Provider</b> will design and conduct a program. Provide most updated review materials, to enable the learners carry out the learning and enable them to maximize results of the programs.  d) The <b>Service Provider</b> will provide one on one Coaching and Mock Examination and Practice for the learners

- d) Provide training materials and organize other necessary arrangements for the participants to attend the training.
- e) Provide one on one Coaching and Mock Examination and Practice for the learners
- f) Prepare and submit the training progress reports for the program, every after Five (5) sessions
- g) Provide Certificates and photographs of the participants.
