### SERVICE AGREEMENT

## **KNOW ALL MEN BY THESE PRESENTS:**

This Agreement is made as of August 06, 2024, at Bonifacio Global City, Taguig City, Metro Manila by and between:

The DEPARTMENT OF ENERGY, a government agency duly organized and existing under the laws of the Republic of the Philippines, with office address located at Energy Center, 34th St., Rizal Drive, Bonifacio Global City, Taguig City, 1632 represented herein by PATRICK T. AQUINO, CESO III, Director of Energy Utilization Management Bureau (EUMB) hereinafter referred to as the "FIRST PARTY."

**JUDITH STO. DOMINGO**, of legal age, Filipino citizen, with residence located at Unit 2101 Celesta Bldg., Cypress Towers, C-5 Road, Ususan, Taguig City, Philippines, herein referred to as the "**SECOND PARTY**."

### WITNESSETH: That

WHEREAS, the DOE is a government institution mandated to prepare, integrate, coordinate, supervise, and control all plans, programs, projects, and activities of the government relative to energy exploration, development, utilization, distribution, and conservation, with a mission of improving the quality of life of the Filipino by formulating and implementing policies and programs to ensure sustainable, stable, secure, sufficient, accessible, and reasonably-priced energy.

WHEREAS, the FIRST PARTY is in need of a technical expert to effectively communicate to the public and relevant stakeholders the introduction of nuclear power in the country's energy mix and to provide sets of recommendations for the government in coming up with a better preparations and implementation of communication on the plans and programs for having nuclear as an option for power generation;

WHEREAS, the SECOND PARTY has signified willingness, to which the FIRST PARTY has accepted, to provide the services needed by the latter;

WHEREAS, the SECOND PARTY possesses the education, technical experience, knowledge, and skills required to perform the scope described herein;

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein and intending to be legally bound, the parties hereby agree to the composition of this agreement:

### I. SERVICES

The Second Party shall render Consultancy Services for the Nuclear Energy Program (NEP) on the effective communication to the public and relevant stakeholders the introduction of nuclear power in the country's energy mix. The highly technical NEP consultant shall also provide sets of recommendations for the government in coming up with a better preparations and implementation of communication on the plans and programs for having nuclear as an option for power generation.

# II. REQUIREMENTS, SCOPE, COVERAGE AND DELIVERABLES

The DOE needs to engage the services of a highly technical consultant that will be able to facilitate the following:

- Identify messaging gaps on the readiness to launch a nuclear energy program in the country following an assessment of the relevant infrastructure issues;
- Develop strategic communication objectives on which to anchor targeted messaging and other components;
- Formulate the crucial core messages for stakeholders and the public to help fill in the identified communication-related gaps;
- Identify specific target audiences for those messages, including champions and channels through which those stakeholders can be effectively reached;
- Come up with a detailed communication implementation plan, laying down strategic content for each issue that will extensively cover the range of information needed by stakeholders;
- Produce content in the form of fact sheets, media releases, statements, graphics cards and
  the like on the anticipated contribution of nuclear energy in the country's power supply mix;
  seed and disseminate them accordingly after approval according to timelines;
- Seed content to relevant media on other countries' beneficial tapping and utilization of nuclear technologies that the Philippines can also gain due advantage from in pursuit of development goals.

### A. CONSULTANCY

The Consultant is expected to provide advice and consultancy services (comments, recommendations to reports, research, studies, policies, etc.) which will ensure the successful implementation of the NEP-CC in relation to:

11. Translate and convert the updated Country Nuclear Infrastructure Profile into formats that are better appreciated by stakeholders;	
12. Draft and disseminate information highlighting the importance of ratifying treaties and agreements and passing laws that are pertinent to the country's capacity to benefit from nuclear energy technologies;	
13. Deliver public affairs and communication support to any other related activities of the NEP-CC.	

# **B. OTHER DELIVERABLES**

 Define and contribute communication-related inputs as applicable to the evaluation of the infrastructure areas relative to the introduction of a nuclear energy program for the country;

- Provide the necessary support and content in various formats, including publications, literatures, speeches, media statements, and messages from the identified priority activities that are deemed vital to gain support for the launch of the country's nuclear power program;
- Formulate communication-related inputs to recommendations necessary to address identified gaps in infrastructure issues.

#### III. CONTRACT / PROJECT / ACTIVITY DURATION

The engagement of the services of the Consultant which shall cover five (5) months, starting 01 August 2024 to 31 December 2024 and termination of services upon expiration of the period covered, will be subject to renewal or extension of services as required and endorsed by the DOE.

#### IV. APPROVED BUDGET FOR THE CONTRACT

The approved budget for the contract (ABC) is Five Hundred Seventy Thousand Pesos (PhP 570,000.00), inclusive of all applicable government taxes in accordance with government procedure.

The budgetary requirements to carry out the services of the Consultant particularly in the submission of inputs, participation to meetings and various activities of the NEP-CC shall be sourced from the NEP-CC Fund.

#### V. THE CONSULTANT

The NEP-CC Technical Consultant shall have the following responsibilities:

- 5.1 Abide with the government auditing principles and terminologies as specified in the Government Accounting Manual and other applicable government rules and guidelines;
- 5.2 Adhere to the agreed scope of work/deliverables which were approved by DOE;
- 5.3 Provide a full report consistent with the content of the approved scope of work/deliverables to the agency at the end of each activity unless otherwise agreed by DOE; and
- 5.4 All information reviewed and recorded by the Consultant would be always treated in full confidentiality.

#### VI. **ELIGIBILITY AND SELECTION CRITERIA**

- 6.1 The Consultant must be PhilGeps Registered;
- 6.2 The Consultant must have at least ten (10) years of experience in the field of communication strategy implementation;
- 6.3 The Consultant has the necessary technical skills and expertise needed to help carry out the required outputs of nuclear energy program;
- 6.4 The Consultant must be knowledgeable on government's processes or with direct experience in related processes;

- 6.5 The Consultant must have published statements, media releases and newsletters or any other related documents;
- 6.6 The Consultant must have an experience in publishing articles;
- 6.7 The Consultant preferably had an experience providing his/her expertise to international body.

### VII. PAYMENT TERMS AND CONDITIONS

- 7.1 The monthly payment of services shall be payable monthly amounting to One Hundred Fourteen Thousand Pesos (Php 114,000.00), gross of tax, inclusive of all applicable government taxes as per government procedure. Payment of compensation shall be released subject to submission of outputs/deliverables as proof of services rendered;
- 7.2. The Consultant shall be assigned at the Office of the Undersecretary and perform tasks and functions as assigned, and provided with whatever is necessary for the undertaking such as but not limited to office space and equipment which shall be provided by the Administrative Services for the Consultant's administrative, transportation and logistical requirements. Any equipment provided shall be reverted back to the DOE upon termination of the Contract;
- 7.3 She/he shall not, however, be designated to a position exercising control or supervision over regular and career personnel and,
- 7.4 In this regard, the Consultant shall coordinate with the NEP-CC and concerned Sub-Committee (SC) to determine the key issues, timelines, and prioritization on the monthly deliverables for approval. The deliverables shall be a recommendation to guide actions of the Undersecretary/Secretary of the DOE.

### Reporting

The Consultant shall submit a monthly accomplishment report as the basis for payment of services rendered to the newly established Nuclear Energy Division (NED) of the Energy Utilization Management Bureau (EUMB) who will facilitate the said payment and coordination among the NEP-IAC.

### **Other Conditions**

The Consultant shall report immediately upon signing of the Contract and remain in force unless revoked by the undersigned and/or competent authority of the Department of Energy.
