# AMENDING ITEM 7 OF DEPARTMENT ORDER (DO) NO. DO2023-01-0002 DESIGNATING THE VICE CHAIRPERSON OF THE TRAINING COMMITMENT AND DEVELOPMENT ASSISTANCE MANAGEMENT COMMITTEE

WHEREAS, on 11 January 2023, the Department of Energy (DOE) issued DO No. DO2023-01-0002, titled "Providing the Interim Guidelines on the Allocation and Availment of the Training Commitment Fund (TCF) and Development Assistance Fund (DAF) Sourced from Energy Service/Operating Contracts and Multi-Client Agreements";

WHEREAS, Item 7 of said DO establishes the creation of the Training Commitment and Development Assistance Management Committee (TC-DA-MC);

WHEREAS, in the same provision, the designated Vice Chairperson of the TC-DA-MC is an Assistant Secretary Supervising the Administrative Services or his/her equivalent official;

WHEREAS, in the current organizational structure of the DOE, there is no official holding such title or position, hence, in the exigency of service, the redesignation is necessary to fill said vacancy so that the Committee can carry on the functions and responsibilities as directed in the DO.

**NOW THEREFORE**, in consideration of the above premises and in the exigency of service, the designation of the Vice Chairperson is hereby amended.

Section 1. Designation of the Vice Chairperson under Item 7 is hereby amended as follows:

Vice Chairperson: Assistant Secretary Supervising the Renewable Energy Management Bureau

A majority of the TC-DA-MC shall constitute a quorum for the transaction of business, provided that the presence of either the Chairperson or the Vice Chairperson shall be required at all times. Provided further, that in the event that the Chairperson or the Vice Chairperson are on official business and cannot perform their tasks, the Chairperson may designate a presiding officer among the members of the Committee to spearhead the meeting.

#### Section 2. Separability Clause.

If any section or provision of this DO is declared invalid or unconstitutional, such part not affected shall remain valid and subsisting.

## Section 3. Repealing Clause.

The provisions of DO No. DO2023-01-0002 which are not inconsistent with this DO shall remain valid and effective.

## **Section 4. Effectivity**
