



# DEPARTMENT ORDER NO. Do 2024- 11-00/3

## GUIDELINES ON THE DEPARTMENT OF ENERGY (DOE) SUSTAINABLE ENERGY AWARDS

WHEREAS, Republic Act (RA) No. 7638, otherwise known as the "Department of Energy (DOE) Act of 1992" declares it the policy of the State to ensure a continuous, adequate, and economic supply of energy through the integrated and intensive exploration, production, management and development of the country's indigenous energy resources;

WHEREAS, Section 5(b) of RA 7638 mandates the DOE to "develop and update the existing Philippine Energy Program which shall provide for an integrated and comprehensive exploration, development, utilization, distribution and conservation of energy resources, with preferential bias for environment-friendly, indigenous, and low-cost sources of energy";

**WHEREAS**, Section 2 of RA 9136, otherwise known as the "Electric Power Industry Reform Act of 2001" or "EPIRA", declares it the policy of the State to promote the utilization of indigenous and new and renewable energy (RE) resources in power generation in order to reduce dependence on imported energy;

**WHEREAS**, Section 37(e)(i) of the EPIRA mandates the DOE to encourage private sector investments in the electricity sector and promote the development of indigenous and RE sources;

WHEREAS, Section 2(b) of RA 9513, otherwise known as the "Renewable Energy Act of 2008" or the "RE Act", declares it the policy of the State to increase the utilization of RE by institutionalizing the development of national and local capabilities in the use of RE systems, and promoting its efficient and cost-effective commercial application by providing fiscal and non-fiscal incentives:

**WHEREAS**, Section 6 of the RE Act provides that all stakeholders in the electric power industry shall contribute to the growth of the RE industry in the country;

WHEREAS, the Department of the Interior and Local Government (DILG) – DOE Joint Memorandum Circular No. 2020-01, or the "Local Government Unit (LGU) Energy Code", underscores the crucial role of LGUs in supporting the development and implementation of RE initiatives and promotes the decentralization of energy planning, encouraging LGUs to take proactive steps in identifying, developing, and utilizing RE resources within their jurisdictions;

**WHEREAS**, the National Renewable Energy Program (NREP), covering the period 2020-2040, seeks to increase the RE share in the power generation mix to 35% by 2030 and 50% by 2040;

**WHEREAS**, the attainment of the above targets requires the concerted efforts of the government, both at the national and local level, participants in the RE industry and other private institutions;

**WHEREAS**, recognizing and publicizing the contribution of stakeholders in the RE sector, such as RE developers, LGUs, and private institutions through a program to be known as the "DOE Sustainable Energy Awards" will encourage wider adoption of best practices in the energy sector; and

**WHEREAS**, it is necessary to establish guidelines that will govern the transparent implementation and execution of said program.

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the DOE hereby issues, adopts and promulgates the following:

**Section 1.** Title. This Department Order (DO) shall be known as the "Guidelines on the DOE Sustainable Energy Awards."

**Section 2. Scope.** This DO shall govern the implementation of the DOE Sustainable Energy Awards.

**Section 3.** Purpose. This DO prescribes the categories, criteria, application procedure and selection process, and other mechanisms for the DOE Sustainable Energy Awards.

**Section 4. Objectives.** The DOE Sustainable Energy Awards celebrate and recognize sustainable initiatives, highlight best practices, motivate investments, and encourage further innovation in the RE sector, towards the attainment of the RE targets under the NREP.

**Section 5. Award Categories.** There shall be three (3) categories for the DOE Sustainable Energy Awards, namely, RE Projects in On-Grid Areas, Private Institutions, and LGUs, described as follows:

**Section 6. Nomination and Selection Process.** The DOE Sustainable Energy Awards shall follow these procedures:

- a. Call for Nominations. The DOE, through the Renewable Energy Management Bureau (REMB), shall announce the official start of the DOE Sustainable Energy Awards through a Call for Nominations. Such Call shall include all relevant information, such as but not limited to, number of awardees for each category, criteria and scoring system, requirements for nomination and evaluation, and timelines for evaluation/validation, deliberation, and awarding.
- b. Intent to Join and Submission of Entries. All interested parties shall be nominated through a duly sworn letter together with the documentary requirements listed in the Call for Nominations. Only those applications with complete submissions shall be considered. Applications submitted beyond the deadline will not be accepted. Furthermore, the DOE reserves the right to accept or reject nominations based on criteria set for a category.
- c. Desk Evaluation/Field Validation. The Sustainable Energy Awards Validation Team (SEAVT) created under Section 7(b) hereof shall review the nominations and their supporting documents through desk evaluation and/or field validation, if necessary, based on criteria set forth in the Call for Nominations.
- d. **Final Deliberation of the Nominees.** The Sustainable Energy Awards Selection Committee (SEASC) created under Section 7(a) hereof shall review and deliberate on the desk evaluation/field validation results. The deliberation results and list of awardees shall be endorsed to the Secretary for approval.
- e. Awarding. Nominees whose endorsement for award was approved by the Secretary shall be conferred the Sustainable Energy Awards.

**Section 7. Selection Committee, Validation Team, and Secretariat.** To ensure the efficient and effective implementation of the activities of this DO, the following are hereby constituted:

a. Sustainable Energy Awards Selection Committee (SEASC). The Committee shall be composed of the following:

Chairperson: Undersecretary supervising REMB
Vice Chairperson: Assistant Secretary supervising REMB

Members: Director, REMB Director

Director, Legal Services Director, Financial Services

b. Sustainable Energy Awards Validation Team (SEAVT). The Validation Team shall be composed of the following:

Head: Assistant Director, REMB

Members: Chief, Biomass Energy Management Division

Chief, Geothermal Energy Management Division

Chief, Solar Energy Management Group Chief, Hydropower and Ocean Energy

Management Division

Chief, Wind Energy Management Group Chief, Investment Promotion Office

c. Secretariat: National Renewable Energy Board -

Technical Services Management Division (NREB-

TSMD)

**Section 8.** Roles and Functions. The SEASC, SEAVT and Secretariat shall have the following roles and functions:

### a. SEASC

- i. Oversee the implementation of, and monitor the activities under, this DO:
- ii. Provide strategic direction and ensure alignment with the overall objectives of the Sustainable Energy Awards;
- iii. Approve the evaluation criteria, including its weighted distribution, ensuring fairness and transparency; and
- iv. Recommend the final list of awardees for approval by the DOE Secretary.

### b. SEAVT

- i. Assess and evaluate applicants/entries;
- ii. Conduct field validation, if necessary, to verify information for all categories;
- iii. Prepare validation reports, if necessary;
- iv. Recommend awardees to the SEASC;

- v. Implement activities for the conduct of the Sustainable Energy Awards consistent with the direction provided by the SEASC;
- vi. Lead the improvements of the guidelines, evaluation process, and other mechanisms; and
- vii. Submit all relevant information and reportorial requirements, as may be required by the SEASC.

### c. Secretariat

- i. Organize committee meetings;
- ii. Manage logistics and documentation of activities related to the Sustainable Energy Awards;
- iii. Secure the integrity and confidentiality of all documents submitted by nominees and arrange documents for the convenience of the SEAVT and SEASC for the conduct of review and evaluation; and
- iv. Provide other administrative support, as necessary.

**Section 9. Evaluation Criteria.** The SEAVT shall develop the evaluation criteria, scorecards, and other relevant mechanisms for the proper discharge of the functions of the SEASC and SEAVT. Nominations for the DOE Sustainable Energy Awards, under the categories specified in Section 5 hereof shall be assessed in accordance with the criteria and scoring system to be outlined in the official Call for Nominations.

**Section 10.** Conduct of Awards. The DOE shall, as far as practicable, conduct the Sustainable Energy Awards annually. The date of the awarding shall coincide with the celebration of the National Energy Consciousness Month (NECM).

**Section 11. Special Recognition.** The DOE may confer special recognition to the following entities that have demonstrated innovation and significant contributions to the development and promotion of sustainable RE initiatives:

- a. RE Projects in Off-grid Areas;
- b. Distribution Utilities:
- c. Civil Society Organizations / Development Partners; and/or
- d. State Universities and Colleges.

This recognition is based on the impact of their projects or contributions to the RE sector.

The SEAVT shall develop the criteria therefor, which must include the significance and impact of the entity's efforts in the RE industry. The determination of awardees shall be made by the SEASC and approved by the Secretary.

**Section 12. Confidentiality.** All submitted information and data shall be treated with utmost confidentiality and can only be used by the DOE for monitoring, planning, policy development, and other official use. No information and data shall be used for profit in any form.

**Section 13. Finality of Decision.** The decision of the SEASC regarding the selection of awardees and recipients of recognition shall be final and irrevocable, and non-appealable, except to the Secretary.

Section 14. Sanctions for Submission of False Information. Any nominator which, upon due investigation/validation, is determined to have submitted nominations containing false or misleading information shall be proceeded against in accordance with applicable laws, rules and regulations, and may result in disqualification of the nominee from any award should such nominee's collusion therein be duly established. Furthermore, the actions of the nominator and/or the nominee, and the latter's subsequent disqualification shall be publicly disclosed in order to maintain the integrity of the awards program and uphold transparency.

**Section 15. Separability Clause.** If for any reason, any section or provision of this DO is declared unconstitutional or invalid, the other parts or provision hereof which are not affected thereby shall continue to be in full force and effect.

Section 16. Effectivity. This DO shall take effect immediately.

With the implementation of the RE Act, interest in renewables has grown.

The Department of Energy (DOE) recognizes the initiatives and contributions of the different stakeholders in promoting renewable energy and transitioning into clean energy. The DOE continues to solicit and highlight the involvement of these stakeholders, in particular the private sector and local government units, in this endeavor.

With this, the DOE is spearheading the 1<sup>st</sup> Sustainable Energy Excellence Award in recognition of the outstanding and exemplary initiatives and significant contributions in the utilization, promotion, and development of RE.

### 2. Objectives

The DOE Sustainable Energy Awards celebrates and recognizes sustainable initiatives, highlight best practices, motivate investments, and encourage further innovation in the RE sector, towards the attainment of the country's RE targets.

### 4. Eligibility for Application

The following qualifications per category shall be met to be eligible for application. Applications that do not meet these eligibility requirements will not be accepted.

### 5. Criteria and Distribution of Scores

Applications will be evaluated based on the contents and information presented in the submitted documents, in reference to sets of established criteria. These criteria focus on outstanding RE initiatives resulting to social, economic, and environmental benefits.

The Aspects for each Criteria will be rated from 1-5 based on the rating scale below. The maximum total point score is 100% based on the criteria distribution shown in Tables 5.1, 5.2, and 5.3

### Rating Scale:

- 5 Excellent, comprehensive evidence, highly credible, and surpassing expectations
- 4 Very Satisfactory, substantial evidence with high credibility and depth
- 3 Satisfactory, evidence substantiates claims with relative credibility
- 2 Fair, limited evidence with lacking depth and credibility
- 1 Unsatisfactory, claims with no supporting evidence
- 0 No submission or did not meet expectation

### 6.2. Application Requirements

Applicants shall submit all the requirements listed below:

- 2. Application Form (Appendix A)
- 3. Duly executed Terms and Conditions (Appendix B)
- 4. Application Checklist (Appendix C)

All submission must be typewritten in single spacing, Arial 11 point font, 1 inch (2.54 cm) margin from all sides, and in A4 size paper. Submission exceeding 20 pages will be automatically disqualified (excluding the nomination letter, the executed Terms and Conditions, and supporting documents / attachments).

### 6.3. Evaluation and Validation

- Sustainable Energy Awards Validation Team (SEAVT) shall review the nominations and their supporting documents through desk evaluation and/or field validation, if necessary, based on criteria set hereof.
- Sustainable Energy Awards Selection Committee (SEASC) shall review and deliberate on the desk evaluation/field validation results. The deliberation results and list of awardees will be endorsed to the Secretary for approval.

 Nominees whose endorsement for award was approved by the Secretary shall be conferred the Sustainable Energy Awards.
