SUBJECT : OCSP4 RESULT

In the 4th Open and Competitive Selection Process (OCSP4), the Department of Energy (DOE) offered twenty (20) Pre-Determined Areas (PDA) for potential RE development, broken down as follows: (14) hydropower; (3) geothermal; and (3) wind study areas as presented in the Department Circular No. DC2023-06-0019, entitled “*Adopting the Guidelines Governing the 4th OCSP in the Award of RE Service Contracts, and for Other Purposes*” or the OCSP4 Guidelines”.

A. OCSP4 Winning Bidders

Pursuant to Section 6.7 of the OCSP4 Guidelines, the following Applications were determined to having met the minimum evaluation criteria, and are hereby declared the winning bidders:
