SUBJECT : EXTENSION OF THE IMPLEMENTATION OF SECTIONS 4 AND
5 OF DC2022-12-0039

Pursuant to Department of Energy (DOE) Circular No. DC2022-12-0039, promulgated on 23 December 2022, the Mindanao WESM commenced its commercial operation last 26 January 2023. Accordingly, the Mindanao Trading Participants' (MTPs) full compliance with the Prudential Requirements (PR), Real-time Monitoring Requirements (RTM) and back-up metering facilities, and Dispatch Conformance Standards (DCS) were relaxed for three (3) months therefrom, or up to 25 April 2023.

In the 20 April 2023 report submitted by the Independent Electricity Market Operator of the Philippines (IEMOP) to the DOE, there are several MTPs that have yet to complete their WESM Registration, as indicated in Annex "A" attached herein. Based on DOE's evaluation of the pending requirements, most are minor documentary requirements. On the other hand, while there are MTPs who have yet to post their prudential requirements, they are on time and fully compliant with settling their financial obligations during the first three (3) months of the commercial operation of the Mindanao WESM. The DOE also recognized that RTM and back-up metering requirements may take time to complete.

In consideration of the foregoing, the DOE is hereby extending the compliance period as follows:

- 1) Additional two (2) months, or up to 25 June 2023, for the submission of the concerned MTPs of complete registration requirements and the PR; and
- 2) For the RTM and back-up metering requirements, the MTP may secure the approval of the Market Operator on the necessary period within which it can fully comply with the requirements, provided that the compliance period shall not be later than 25 December 2023.

Regarding the DCS, it shall be fully enforced starting 26 April 2023. All concerned MTPs shall ensure their full compliance thereto, in accordance with the WESM Rules and Market Manuals. In this regard, the Philippine Electricity Market Corporation-Enforcement and Compliance Office shall impose penalties on MTPs who violate the DCS in accordance with the provisions of the WESM Penalty Manual.

In addition, all MTPs with lacking registration requirements are enjoined to submit their Compliance Plan to the DOE and IEMOP on or before 15 May 2023 in line with the relaxation provided hereof. Meanwhile, immediate compliance of concerned MTPs with the pending requirements is earnestly sought.

Upon the lapse of the extended relaxation period, the Market Operator and the WESM Governance Arm shall undertake appropriate action pursuant to the WESM Rules.
