A. Introduction

1. This has reference to the Annual Procurement of Outsourced Manpower Services for Fiscal Year (FY) 2023.

B. Mandate

2. Administrative Service - Administrative Order No. 38, s. 2002 dated 23 August 2002, states that the Administrative Support Service shall formulate and implement policies, programs and regulations in human resource relations as well as coordinate activities for special events in the DOE.
3. Human Resource Management Division - formulates policies, plans and programs related to the department's human resource management and ensures effective implementation thereof and compliance with government regulations and standards.

C. Facts

4. LSERV Corporation is the Single Calculated Responsive Bidder during the Public Bidding for the procurement of outsourced manpower services FY 2023, which was conducted by the DOE Bids and Awards Committee on 14 February 2023
5. The Contract Agreement shall be for a period of ten (10) months, from 01 March 2023 to 31 December 2023, with a contract price of Seventeen Million, Five Hundred Eleven Thousand, Four Hundred Fifty-One pesos and 47/100 (PHP 17,511,451.47).


