

CONTRACT AGREEMENT

THIS AGREEMENT made the 26 day of APRIL 2023 between **DEPARTMENT OF ENERGY (DOE)** of the Philippines (hereinafter called "the Entity") of the one part and **I-SECURE NETWORKS & BUSINESS SOLUTIONS INC.** of **10/F, Cityland Shaw Tower, Shaw Blvd., corner St. Francis Brgy. Wack Wack, Mandaluyong City** (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Server Network Infra and Security Software License Maintenance and Support Services – Lot 3: ICT Infrastructure Services Management and Monitoring Software for the Department of Energy (DOE)**, and has accepted a Bid by the Service Provider for those goods and services in the sum of **Six Million Three Hundred Thousand Pesos Only (Php6,300,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract;
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Six Million Three Hundred Thousand Pesos Only (Php6,300,000.00)** or such other sums as may be ascertained, **I-Secure Networks & Business Solutions Inc.** agrees to the **Server Network Infra and Security Software License Maintenance and Support Services – Lot 3: ICT Infrastructure Services Management and Monitoring Software for the Department of Energy (DOE)** in accordance with its Bid.
4. The **Department of Energy** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






