- iii. Wondershare EdrawMax - Bidder's **Notarized Declaration that they will source this item from the developer or licensed/authorized distributor/reseller is acceptable in lieu of the Certificate of Distributorship and is required to be included in the bid submission**
- iv. Homer Grid - Bidder's **Notarized Declaration that they will source this item from the developer or licensed/authorized distributor/reseller is acceptable in lieu of the Certificate of Distributorship and is required to be included in the bid submission**
