

## CONTRACT AGREEMENT

THIS AGREEMENT made the \_\_\_\_\_ day of \_\_\_\_\_ 2024 between **DEPARTMENT OF ENERGY (DOE)** of the Philippines (hereinafter called "the Entity") of the one part and **CARE BEST INTERNATIONAL SECURITY SERVICES, INC.** of 6111 Unit 8A, 8/F GMA Lou-Bel Plaza Condominium Bldg., 7514 Bagtikan St. corner Pasong Tamo San Antonio Village, Makati City (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **DOE CY2024 Security Services (Multi-year Contract)** and has accepted a Bid by the Service Provider for those services in the sum of **Twelve Million One Hundred Forty-Three Thousand Eight Hundred Forty-Seven Pesos and Thirty Centavos Only (PhP12,143,847.30)** for the **Second Year under a Multi-Year Contract** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Technical Specifications;
    - ii. General and Special Conditions of Contract; and
    - iii. Other Conditions of the Contract (Annex "A", "B", "C", "D", "E")
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Twelve Million One Hundred Forty-Three Thousand Eight Hundred Forty-Seven Pesos and Thirty Centavos Only (PhP12,143,847.30)** for 6-month period (July-December 2024) or **Two Million Twenty-Three Thousand Nine Hundred Seventy-Four Pesos and Fifty-Five Centavos (PhP2,023,974.55 per month)** or such other sums as may be ascertained, **Care Best International Security Services, Inc.** agrees to **DOE CY2024 Security Services (Multi-year Contract)** in accordance with his/her/its Bid for the Second Year of the Multi-Year Contract.
4. The **DEPARTMENT OF ENERGY (DOE)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


