

**CY 2023 CONTRACT ON SECURITY SERVICES FOR DOE MINDANAO FIELD
OFFICE PREMISES, DOE-MFO LEASED OFFICE AREA AT TOLENTINO BUILDING,
AND DOE-MFO WAREHOUSE IN DAVAO CITY**

THIS CONTRACT made this ____ day of _____ 2023 by and between the **DEPARTMENT OF ENERGY (DOE)** with office address at Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, Philippines (hereinafter called "**the Entity**") of the one part, and **AXZEEN SECURITY SERVICES, INC.** with principal place of business located at L2, B14, Phase 1, Diho Subdivision, Cabantian, Buhangin, Davao City, Philippines (hereinafter called "**the Contractor**") of the other part.

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., the **Security Services for DOE-MFO Main Office premises in 3F Tolentino Building, Candelaria Avenue, Ecoland, Davao City and DOE-MFO Warehouse in Purok 5, Bankas Heights, Toril, Davao City**, respectively and has accepted a Bid by the Contractor in the sum of **Three Hundred Ninety-Seven Thousand Four Hundred Thirteen Pesos and Eighty Centavos Only (Php 397,413.80)** or **Ninety-Nine Thousand Three Hundred Fifty-Three Pesos and Forty-Five Centavos Only (Php 99,353.45)** monthly with additional **Thirty-Five Thousand Four Hundred Twenty Pesos Only (Php 35,420.00)** for one time payment in consideration of the equipment and supplies provided with a total amount of **Four Hundred Thirty-Two Thousand Eight Hundred Thirty-Three Pesos and Eighty Centavos (Php 432,833.80)** (hereinafter called "**the Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

3. **Contract Period:** 01 September to 31 December 2023
4. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
5. The Entity hereby covenants to pay the Contractor in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by the Contract, subject to applicable withholding tax.






