

CONTRACT AGREEMENT

THIS AGREEMENT made the _____ day of _____ 2024 between **DEPARTMENT OF ENERGY (DOE)** of the Philippines (hereinafter called "the Entity") of the one part and **PHILCARE MANPOWER SERVICES** of **6111 Albert Street, Poblacion, Makati City** (hereinafter called "the Service Provider") of the other part;


WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **DOE CY2024 Janitorial Services (Multi-year Contract)** and has accepted a Bid by the Service Provider for those services in the sum of **Nine Million Seven Hundred Sixty Thousand Nine Hundred Ninety-Nine Pesos and Sixty-Two Centavos Only (Php9,760,999.62)** for the Second Year under a Multi-Year Contract (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Technical Specifications;
 - ii. General and Special Conditions of Contract; and
 - iii. Other Conditions of the Contract (Annex "A", "B", "C", "D")
 - ii. Performance Security;
 - iii. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Nine Million Seven Hundred Sixty Thousand Nine Hundred Ninety-Nine Pesos and Sixty-Two Centavos Only (Php9,760,999.62)** for 6-month period (July-December 2024) or **One Million Six Hundred Forty-Seven Thousand One Hundred Thirty-Four Pesos and Seventy-Seven Centavos (Php1,626,833.27 per month)** or such other sums as may be ascertained, **Philcare Manpower Services** agrees to **DOE CY2024 Janitorial Services (Multi-year Contract)** in accordance with his/her/its Bid for the Second Year of the Multi-Year Contract.
4. **The DEPARTMENT OF ENERGY (DOE)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
