Subject : **DEADLINE OF SUBMISSION AND OPENING OF APPLICATION DOCUMENTS FOR PDA FOR PETROLEUM IN THE BARMM (PDA-BP-1, PDA-BP-2, & PDA-BP-3)**

Date : **13 AUGUST 2024**

Following the Timeline of Activities for the 1st BARMM Conventional Energy Bid Round, the deadline for submission of application documents for Petroleum Service Contracts in the BARMM is on **27 August 2024 (Tuesday), at 1100H [GMT+8 - Philippine Standard Time (PST)]**.

In view thereof, this Joint Advisory is issued for the information and guidance of all concerned. Thus:

- (1) Application Documents for PDA-BP-1, PDA-BP-2, & PDA-BP-3 may still be submitted at the **Ministry of Environment, Natural Resources and Energy (MENRE) Office until 16 August 2024, 1700H (PST)**.
- (2) The MENRE and the DOE shall set-up a **ONE-STOP-SHOP** for the processing of payment and receipt of application documents at the **Department of Energy - Energy Resource Development Bureau (ERDB) Office on 19 August 2024 from 1400H to 1700H (PST), & 20-23 August 2024, excluding holiday (21 August 2024), from 0800H to 1700H (PST)**.

Thereafter, the **ONE-STOP-SHOP** shall be transferred to **Dusit Thani Manila, Ayala Center, 1223 Makati City, Metro Manila, Philippines** on **27 August 2024 from 0700H to 1100H (PST) ONLY** to continue facilitating the processing of payments and submission of application documents.

- (3) The Opening of Application Documents shall be conducted at **Dusit Thani Manila on 1330H (PST)**.



- (4) Reiteration of Section 9.B of the IEB Circular: Payment of a non-refundable application fee in the amount of P200,000.00 to be paid as follows:
- (i) P100,000.00 payable to the DOE.
 - (ii) P100,000.00 payable to the MENRE.

Application fees may be paid in cash or manager's check. In case of check payments, applicants must prepare two (2) checks - 1 check in favor of the DOE and 1 check in favor of the MENRE, for **P100,000.00 EACH**.

- (5) The official time for the End of Bid Round for PDA-BP-1, PDA-BP-2, & PDA-BP-3 will be based on Philippine Standard Time (PST) as published on the DOST-PAGASA website.
