

 - d. Active email Address where the invitation/link will be sent; and,
 - e. Other contact details.
 - 4.3. The MGSP SBAC Secretariat, upon registration will send a meeting link to their respective email address to access the meeting virtually. **Only registered participants will be admitted.**
5. The submission deadline shall be no later than 9:00 AM of **08 November 2024**, Manila Time. Any late submissions will not be accepted and shall be received and stamped by the **DOE Records Management Division** at the DOE Main Building Annex Lobby of the above address.
