**A RESOLUTION ENDORSING FOR APPROVAL BY THE SECRETARY OF THE DOE
CY 2015 ANNUAL PROCUREMENT PLAN (APP) SUPPLEMENTAL NO. 8**

WHEREAS, Section 7.2, Rule II of the revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184 states that no government procurement shall be undertaken unless it is in accordance with the approved Annual Procurement Plan of the procuring entity;

WHEREAS, the DOE-Bids and Awards Committee (DOE-BAC) in coordination with the different operating units of the Department including Project Management Offices (PMOs), had prepared an Annual Procurement Plan (APP) for CY 2015 approved by OIC-Secretary Zenaida Y. Monsada;

WHEREAS, the DOE-BAC through its Secretariat received subsequent request from various operating units for their additional procurement requirements for the current year and change of procurement mode, thus the need to have a Supplemental APP No. 8;

WHEREAS, the Department's Supplemental APP No. 8 shall be subsequently submitted to the Government Procurement Policy Board (GPPB) pursuant to Section 7.4, Rule II of IRR of said Act which states among others that:

“Section 7.4. Updating of the individual Project Procurement Management Plan and the consolidated APP for each procuring entity shall be undertaken every six (6) months or as often as may be required by the Head of Procuring Entity.”

NOW, THEREFORE, in view of the foregoing, and upon motion duly-made by Asst. Dir. Rodela I. Romens as proponent of the activity, be it:

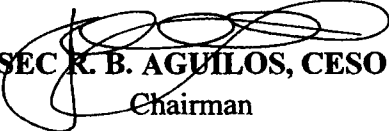

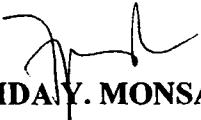

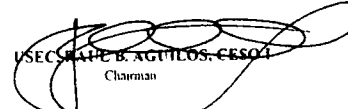
