INSTRUCTION FOR SUBMISSION

CATEGORIES

- 2. For candidates for Energy Efficiency Excellence Awards for Government, nominees shall be based on the compliance to Government Energy Management Program (GEMP).
- 3. For candidates for Energy Efficiency Excellence Awards for Outstanding / Groups, **SELF-NOMINATION** is not allowed.

REGISTRATION AND SUBMISSION

All interested parties, except EEE Awards for Government, shall upload the following to the online platform indicated below:

- a. Expression of Interest Form;
- b. Self-Assessment Form; and
- c. Pictures for Building Categories.

Upon receipt of the submission, the Department of Energy (DOE) shall notify the FINALIST on or before 07 October 2021 to submit supporting documents and documentations for evaluation proper.

For submission of pictures:

- a. Structure, including exteriors and interiors
- b. Building features
- c. Officials

Guidelines in taking pictures:

- a. High definition
- b. Landscape
- c. Shot using DLSR or any camera (not cellphone camera)
- d. Proper lighting (preferably natural light)
- e. Proper framing



SUBMISSION/NOMINATION RULES

- 1. The Energy Efficiency Excellence Awards is open to all Filipino Citizens aged 18 and above.
- 2. For Energy Service Company (ESCO) nominees, they should be either certified or registered to the DOE.
- 3. For Energy Conservation Officer, Energy Manager, and Energy Auditors, they should be able to provide proof of experience validated by their immediate supervisor or certificate from clients.
- 4. All nominees should accomplish the self-assessment requirements as a prerequisite for the evaluation of finalists in the 2021 EEE Awards.
- 5. All official finalists after the evaluation will be notified by the DOE and shall proceed with the submission of necessary documents.
- 6. All documents shall be in accordance with the template and guide documents provided the DOE.
- 7. All submissions shall be made online and through this link:

Submissions made through e-mail or hard copies sent to the DOE will be considered as invalid entries and will NOT be part of the official entries in the EEE Awards.

- 8. All submitted documents are deemed final. The nominees/participants can no longer edit or replace their submitted documents. The nominees and applicants are prohibited from directly communicating with the DOE EE Awards Validation Committee during the evaluation period of the submission.
- The nominees/participants will receive an update whether they are qualified as finalist or not. The number of finalists will depend on the number of submissions and on the decision of the DOE EE Awards Validation Committee and Selection Committee.
