**Resolution No. 088, s. 2023**

**A RESOLUTION ENDORSING FOR APPROVAL BY THE SECRETARY THE DOE  
CY 2023 ANNUAL PROCUREMENT PLAN (APP) SUPPLEMENTAL NO. 01**

**WHEREAS**, Section 7.2, Rule II of the revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) No. 9184 states that no government procurement shall be undertaken unless it is in accordance with the approved Annual Procurement Plan of the procuring entity;

**WHEREAS**, the DOE-Bids and Awards Committee (DOE-BAC) in coordination with the different operating units of the Department including Project Management Offices (PMOs), had prepared an Annual Procurement Plan (APP) for CY 2023 approved by Secretary Raphael P.M. Lotilla;

**WHEREAS**, the DOE-BAC through its Secretariat received subsequent request from various operating units for their additional procurement requirements for the current year and change of procurement mode which have been reviewed by the BAC-TWG, Budget Division and Procurement Management Division, thus the need to have a Supplemental APP No. 01;

**WHEREAS**, SAPP No. 1 includes items not included in the APP 2023 as well as items that were re-aligned, change in modes and project titles and items from CY2022 budget that will still be procured;

**WHEREAS**, RA 9184 and its Implementing Rules and Regulations allows the revision/amendment of the Annual Procurement Plan, as follows:

*“Section 7.4. Updating of the individual Project Procurement Management Plan and the consolidated APP for each procuring entity shall be undertaken every six (6) months or as often as may be required by the Head of Procuring Entity.”*

**WHEREAS**, there is a need, thereafter, to submit SAPP No. 01 to the Government Procurement Policy Board (GPPB) pursuant to R.A.9184 and its IRR;

**NOW, THEREFORE**, in view of the foregoing, and upon motion duly made **Mr. FEDERICO G. DOMINGO, JR.**, the Head of the BAC Secretariat, the BAC has resolved, as hereby it is, **RESOLVED** to:

1. **APPROVE** the Supplemental Annual Procurement Plan No.1 as presented and to endorse to the Secretary the approval of the DOE-CY2023-SAPP No.1 as follows:
